Qualified equipment must be connected to a National Grid meter and be on firm commercial rate paying the System Benefits Charge (SBC). Customer cannot receive an incentive from National Grid and an incentive from NYSERDA for the same equipment. Multifamily buildings (5 units or greater) in New York City and Long Island service territories are not eligible to receive incentives through this program. Please refer to National Grid's Energy Efficiency Natural Gas Solutions for Multifamily Buildings program for New York City.

This program is available for installations completed between 1/1/2023 and 12/31/23. Rebate form and required documentation must be postmarked within 60 days of equipment installation date, but no later than 12/31/23.

Issuance of incentives for completed applications is contingent upon program availability. Check **ngrid.com/business** frequently for program updates and installation extensions. Due to limited funding, the program may be terminated at any time.
